

Privacy Notice Oil and Gas Transition Training Fund Pilot

Who are we?

The Skills Development Scotland Co Ltd ("SDS", "we", or "us") is the national skills body supporting the people and businesses of Scotland to develop and apply their skills.

The Oil and Gas Transition Training Fund Pilot

The UK Government's Office for Clean Energy Jobs (OCEJ) Regional Skills Pilot for Aberdeen and Aberdeenshire is being delivered by The Skills Development Scotland on behalf of Scottish Government to develop targeted sustainable energy/low carbon skills interventions in Aberdeen and Aberdeenshire.

SDS will provide funding under the Oil & Gas Transition Training Fund (OGTTF) Pilot, to assist individuals servicing the oil and gas industry sector in Scotland, who have a demonstrable need to acquire new skills and/or learning for the purposes of obtaining work in the Sustainable/Renewable Energy Industry sector, to undertake appropriate re-training.

Who is this Privacy Notice for?

This Privacy Notice provides information to participants on the OGTFF Pilot around how their personal data will be processed, shared, and stored.

What personal information do we collect and process?

- Information that you provide about you and your personal circumstances.
 This may include (but without being limited to) name, date of birth,
 National Insurance Number, employment history and qualifications
- Contact information that you provide. This includes email address, phone number and postal address.
- Information you provided about yourself in the SDS equalities monitoring form and any disability or care leaver form (most of which is known as special category or sensitive data). This includes information concerning ethnicity, gender identity, religious beliefs, sexual orientation, health data (e.g. disability). It also includes information relating to care experience.

How do we use your information?

Special category information (e.g. ethnicity, disability, sexual orientation)	To carry out equalities monitoring and to ensure we meet our Equality Act 2010 obligations, including the public sector equality duty	Fair and lawful because it is: necessary for SDS to comply with its legal obligations necessary for reasons of substantial public interest, paragraph 8 of Schedule 1 of the Data Protection Act 2018 (Equality of opportunity or treatment).

Personal information and Special category information (e.g. ethnicity, disability, sexual orientation)	To undertake statistical research regarding the value and impact of the OGTTF Pilot and to assist policy development.	Fair and lawful because it is: necessary for SDS to perform a task in the public interest necessary for reasons of substantial public interest, paragraph 8 of Schedule 1 of the Data Protection Act 2018 (Equality of opportunity or treatment).

When might we share your information?

The information collected shall be held by us or on our behalf and may be passed by us to other public bodies, including the Scottish Government and UK Government and third-party evaluators, concerned with one or more of the following:

- economic development
- skills development
- awards for vocational qualifications
- maintaining educational standards
- the provision of other public services or benefits
- our internal/external auditors in each case, to the extent required to fulfil their respective public functions.

The information you provide to us about aspects such as your ethnicity, gender and religion in the Equality Monitoring Form will be passed to Scottish Government and UK Government in an anonymised format as we are required to report on this information under the Equality Act (2010).

How do we protect your information?

Skills Development Scotland maintain a high standard of both physical and network security designed to protect paper or electronic forms of storage to hold and process your personal information.

Information that we hold about you will be subject to rigorous safeguards to ensure that it isn't accessed or disclosed inappropriately. We also take steps to ensure that your information is not damaged or rendered unavailable to those who have a right to see it.

To meet confidentiality requirements for our customers, stakeholders, and staff, Skills Development Scotland has Confidentiality, Data Protection and Information Technology notices in place, and we ensure that staff are fully aware of these and the associated guidance in relation to your personal information. These also apply when we dispose of paper records and delete electronic information in ways that ensure that your information cannot be recreated.

How long do we store your information?

Once you have been verified as a participant under the TTF programme, your personal information will be stored in our systems for 7 years after the final payment of training. This is to allow a period for us to audit, monitor, and evaluate participants on the fund.
